Climate Action Africa supports the deployment of short-term technical assistance and results-oriented South-South knowledge exchanges between Sub-Saharan Africa countries, facilitating the sharing of climate-related expertise and lessons learned.

Based on needs identified at the local level, the Expert Deployment Mechanism for Climate Action Africa Project deploys Canadian climate change experts to partner with governments, NGOs, the private sector, civil society organizations and post-secondary institutions on targeted, short-term technical assistance projects in support of implementation of the Paris Agreement across the region - with a focus on increasing women's capabilities to fully participate as active agents of change.

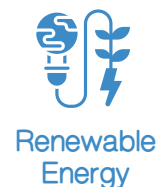


Women's Participation and Leadership in Climate Action
